

Lewis Creek Association 2015 Program Highlights

This year your contributions helped leverage government grants for education, restoration and conservation projects the middle Lake Champlain towns. LCA continues to work with a growing network of partners to educate residents while working to improve the health of land and water resources in two counties and seven towns. Our partner groups include government groups, LaPlatte Watershed Partnership, Lake Iroquois Association, South Chittenden Riverwatch, Addison County Riverwatch Collaborative, Vermont Family Forests, state and local land trusts and conservancies, and two new regional groups - Watersheds United Vermont and Vermont Water Monitoring Council. 2014 grant funds came from Lake Champlain Basin Program and VT ANR.

In 2015, the board was thrilled to welcome Shelburne resident and Ecologist Susan Moegenburg who has been co leading stream monitoring work of the South Chittenden River watch since 2004. Program Highlights (\$100,000 annual budget)

Restoration and Conservation (15% of budget)

We reached our fundraising target and celebrated our gift of \$120,000 to Town of Monkton who is now installing VT's first two amphibian and wildlife underpasses in Monkton Vermont.
